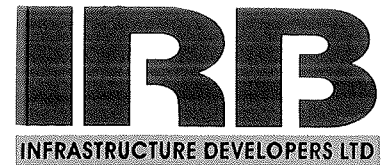

Pursuant to the demonetization, NHAI announced stoppage of toll collection at all toll roads in India from November 09, 2016 until December 02, 2016.
